

## REPETITIVE INVITATION FOR SUBMITTING OFFERS

Piraeus Port Authority S.A. is interested in proceeding with a repetitive tender regarding the award of a two (2) year period contract regarding the provision of maintenance and repair services for fifty (50) Vehicle Mounted Terminals (VMTs), in accordance with the attached updated technical description and terms, of budget 45.000,00 euros.

Award criterion shall be the **lowest price** for the entire described list of PPA S.A. Vehicle Mounted Terminals (VMTs).

Interested parties are invited to submit their offer (alternative/second offers are excluded) until **1<sup>st</sup> of March 2024** at 16:00 by email to the following email address: [offersubmission@olp.gr](mailto:offersubmission@olp.gr). Offer submission will be completely electronically through email as follows:

1. Each offer should consist of two (2) individual folders: **a.** the technical offer including any participating documentation needed according to tender terms and **b.** the financial offer which should be protected with separate/different passwords. The passwords will be sent to PPA S.A. separately at each evaluation stage of the tender to a specific e-mail which will be notified by the PPA S.A. to all participants.

The offers' files **only** (not the passwords) should be sent directly to Procurement Department by the candidates at the following e-mail: [offersubmission@olp.gr](mailto:offersubmission@olp.gr). before the tender's expiry deadline with the indication: "*Repetitive Tender - Provision of maintenance and repair services for fifty (50) Vehicle Mounted Terminals (VMTs)*". The maximum acceptable size of each electronic offer should be 5-7 Mbytes, while the acceptable type of offers' compression is .zip (not .rar)

2. On the date and time of each evaluation stage (i.e. participating documentation – if applicable, technical evaluation, financial evaluation), the requested passwords **only** (different password for each stage) should be sent to the group email which will be notified by PPA S.A. to all participants in due time with the indication: "*Repetitive Tender - Provision of maintenance and repair services for fifty (50) Vehicle Mounted Terminals (VMTs)*".

Within the technical offer the following must be included:

- Full business profile (i.e. company profile presentation, company organization, size & capabilities, offered services, customers, previous certification & reporting works etc.)
- Recent Economic Data proving financial adequacy (i.e. tax certificate, published financial statements etc.),
- Description of all offered maintenance & repair services,
- A Candidate's statement that the invitation's terms and requirements are accepted.
- Candidate's compliance with quality standards must be included, if available (i.e. ISO 9001 etc.).

Candidates also have to read carefully the attached Technical Description & Terms file, for more information regarding their offer's content.
