INVITATION FOR SUBMITTING OFFERS

Piraeus Port Authority S.A. is interested in proceeding with the removal and installation of X-ray & Magnetic gates for the needs of PPA SA, of budget 29.100,00 euros.

Award criterion shall be the lowest price per LOT (LOT 1: Items 1,2 & 3, LOT 2: Item 4), provided that all relevant requested terms and conditions are met. Selective Bidding within a LOT is not allowed. Interested candidates may submit offer for one (1) or more lots.

Interested parties are invited to submit their offer (alternative/second offers are excluded) until **12th of March, 2025 at 15:00 p.m. (Greece time)** by email to the following email address: offerssubmission@olp.gr.

Offer submission will be completely electronically through email as follows:

- Each offer should consist of two (2) individual folders:
 - the technical offer including any participating documentation required according to tender terms and;
 - the financial offer which should be protected with separate/different passwords.
- Both aforementioned folders should be protected with separate/different passwords. The passwords will be sent to PPA separately at each evaluation stage of the tender to a specific e-mail which will be notified by the PPA to all participants.
- The offers' files **only** (not the passwords) should be sent directly to Procurement Department by the candidates at the following e-mail: offerssubmission@olp.gr before the tender's expiry deadline with the indication: *"Offer for the removal and installation of X-ray & Magnetic gates for the needs of PPA SA"*. The maximum acceptable size of each electronic offer should be 5-7 Mbytes, while the acceptable type of offers' compression is .zip (not .rar).
- On the date and time of each evaluation stage (i.e. participating documentation – if applicable, technical evaluation, financial evaluation), the requested passwords **only** (different password for each stage) should be sent to the group email which will be notified by the PPA to all participants in due time with the indication: *"Offer for the removal and installation of X-ray & Magnetic gates for the needs of PPA SA"*.

Within the technical offer the following must be included:

- Candidate's Articles of Incorporation, Partnership or Corporation, whichever is applicable or equivalent foundational documents. For domestic companies (Greece), this includes any amendments and the latest Articles of Representation (e.g., Government's Gazette and/or GEMI declaration). For international companies, equivalent documents according to their national legal framework, including any amendments and the latest representation documents or certificates, must be provided.
- Certificate of Registration from host country's government agency/ministry (GEMI).
- A social security clearance certificate valid and in force.
- A tax clearance certificate valid and in force.
- Proof of successful implementation of similar completed projects during the last three (3) years (2022-2024), related to the Installation of X-Ray equipment and magnetic gates, such as contracts, good performance certificates etc., from the clients, accompanied by the client's complete contact details.
- Candidates must provide evidence from the OEMs of the X-ray and magnetic gates, demonstrating certifications for the installation and setup of such equipment.
- A signed solemn declaration by the candidate, signed by a legal representative (accompanied by the current representation certificate), stating that the offer complies with the terms and conditions of the present tender and its annexes.

The offers shall bind the Candidates for two (2) calendar months from the submission deadline date. Any offer which sets forth a term of validity less than the above mentioned shall be rejected.

Interested Parties may receive additional information or clarifications in relation to this Invitation for Submitting Offers, until three (3) days included, prior to the expiry of the time limit for offers submission, by submitting questions in writing to the Procurement Dpt.
